

Step Requirement of Owner's Consent

Before an Application can be made the Owner of the Site (i.e. Government) must give consent to allow a planning application to be submitted

TOWN PLANNING BOARD GUIDELINES ON SATISFYING THE 'OWNER'S CONSENT/NOTIFICATION' REQUIREMENTS UNDER SECTIONS 12A AND 16 OF THE TOWN PLANNING ORDINANCE

1. Introduction

- 1.1 In submitting an application for amendment of plan under section 12A or planning permission under section 16 of the Town Planning Ordinance (the Ordinance), the applicant must comply with the requirement under section 12A(3)(a) or 16(2)(a) of the Ordinance by:
 - (a) obtaining the consent of <u>or</u> notifying each and every 'current land owner' of the
 application site in writing if he is not the 'current land owner' or the sole
 'current land owner' (hereinafter referred to as the 'owner's consent' and
 'owner's notification' requirements respectively); or

Step 2 The Application and Required Broad Technical Content

What Sort of Planning Application?

a) A **Planning Application** is required as development is not currently permitted according to the provisions of the current Outline Zoning Plan (OZP).

b) An application under the provisions of **Section 12A of the Town Planning Ordinance** (a Rezoning Application) is required to amend the present Outline Zoning Plan to allow the required marine and other ancillary facilities to be permitted as of right.



Technical Content of the Section 12A Application

- a) A Planning Statement (PS) justifying the development and outlying why it is required.
- b) The PS is required to be accompanied by Supporting Technical Assessments e.g. Traffic Impact Assessment, LVIA, Urban Design Assessment, Sewage Impact Assessment, Broad Environmental Assessment, and MTIA etc.
- c) Supporting technical drawings and illustrations, visualisations and plans and elevations and architectural drawings are also required if pertinent to the application.
- d) Other material content that may be beneficial to the application.
- e) All above to be prepared by consultants
- f) A completed official application form.





- 1. THE LAHDLORD LETS AND THE TEMANT TAKES from the 12th day of April 1989 ALL THAT piece or parcel of ground short particulars of which are set out in the First Schedule hereto and for the purpose of identification only shown coloured pink on the plan annexed hereto TOGETHER WITH such structures erected or to be erected thereon or on part thereof as are specified in the Second Schedule hereto (which land and structures are hereinafter referred to as "the Premises") for the term, at the rent and for the purpose specified in the First Schedule.
- 2. THE TEMANT HEREBY AGREES WITH THE LANDLORD as follows :-
 - (a) To pay the rent specified in the said First Schedule, if demanded, on the days and in the manner determined by the District Lands Officer/Hong Kong South (hereinafter referred to as "the District Lands Officer") and notified to the Tenant in writing;
 - (b) Not to use or permit or suffer the use of the Premises or any part thereof for any purpose other than such purposes as are specified in the said First Schedule and Special Condition 5(a) hereto;
 - (c) Not to erect or allow to remain on the Premises any structures (other than those specified in the said Second Schedule) without the prior written consent of the District Lands Officer;
 - (d) Not to alter or demolish any structure engained in the gold

A AGREEMENT made this 30 day of JUNE 1992 Between the Governor of Hong Kong (hereinafter referred to as "the Landlord") of the one part and Aberdeen Boat Club Limited, a company with limited liability incorporated in Hong Kong under the Companies Ordinance and having its registered office situated at 20 Shum Wan Road, Aberdeen, Hong Kong (hereinafter referred to as "the Tenant") of the other part AND IS SUPPLEMENTARY to a Tenancy Agreement (Ref. HX-899) dated the 16th day of March 1990, made between the same parties hereto (which Tenancy Agreement is hereinafter referred to as "the Principal Agreement") AND WHEREAS the parties hereto are desirous of altering the terms of the Principal Agreement in manner hereinafter appearing NOW THEREFORE IT IS HEREBY MUTUALLY AGREED BY AND BETWEEN THE PARTIES as follows:-
